<u>Description of Foreseeable Impact</u>: These network changes will create the potential for spectral interference on the CO-based ADSL and/or a Digital Design Loop (DDL) loops that share the same binder groups as the RT ADSL within the copper distribution feeder cable past the Feeder Distribution Interface (FDI).

<u>Description of Change</u>: Fairpoint Communications NNE will install Digital Subscriber Line Access Multiplexer ('DSLAM') or Litespan to provide Digital Subscriber Line (DSL) service from a Remote Terminal (RT) that is less than 30,000 feet from the Central Office and only when cooper feeder is present between the Central Office and RT.
