NOTICE OF UNLICENSED OPERATION

Case Number: EB-FIELDSCR-17-00024574

On May 3, 2018, Agents from the Miami Office (Miami Office) of the Federal Communications Commission's (FCC's or Commission's) Enforcement Bureau (Bureau) confirmed by direction finding techniques that radio signals on frequency 89.5 MHz were emanating from a single family residence on Northwest 8th Avenue in Miami, Florida. Through investigation, the Miami Office has determined that you are the operator of the radio station. The Commission's records show that no license was issued for operation of a broadcast station at this location on 89.5 MHz in Miami, Florida.

Radio stations operating on a range of frequencies,¹ including 89.5 MHz, must be licensed by the FCC pursuant to Section 301 of the Communications Act of 1934, as amended (Act).² The only exception to this licensing requirement is for certain transmitters using or operating at a power level that complies with the standards established in Part 15 of the Commission's rules.³ On May 3, 2018, Agents made field strength measurements of the signal on frequency 89.5 MHz, which exceeded the maximum permitted level of 250 microvolts per meter (μ V/m) at 3 meters for non-licensed devices. Thus, this station is operating in violation of Section 301 of the Act.⁴

You are hereby warned that operation of radio transmitting equipment without a valid radio station authorization constitutes a violation of the Federal laws cited above and could subject the operator to severe penalties, including, but not limited to, substantial monetary fines, *in rem* seizure of the offending radio equipment, and criminal sanctions including imprisonment.⁵

**UNLICENSED OPERATION OF THIS RADIO STATION MUST BE DISCONTINUED
IMMEDIATELY AND MUST NOT RESUME.**

This will include any information that you disclose in your reply.
