**Network Change:**

Madison Telephone Company will make changes necessary to support the collapse of the Worden WRDNILXERS0, Hamel HAMLILXERS0, Livingston LVNMILXERS0 and Prairietown PATWILXERS0 remotes switches into the Staunton STTNILXEDS0 switch. All special access circuits will be rehomed to Staunton. The WRDNILXERS0 switch was located at Rear of Wall & Lincoln, Worden, IL 62097, the HAMLILXERS0 switch was located at 118 East State Street, Hamel IL 62046, the LVNMILXERS0 switch was located at Central Tel Co of IL, Livingston IL 62058, and the PATWILXERS0 switch was located at Rear of Madison & Schiller, Prairietown, IL 62097. The Staunton (STTNILXEDS0) switch is located at 315 W Main Street, Staunton, IL 62088.

**Description of Type of Changes:**

The purpose of this Network Disclosure is to provide pertinent information regarding the collapse of the Worden WRDNILXERS0, Hamel HAMLILXERS0, Livingston LVNMILXERS0 and Prairietown PATWILXERS0 remotes switches into the Staunton STTNILXEDS0 switch during the third quarter of 2018.
