Application for permit to deliver programming from Local Media San Diego, LLC ("LMSD") to broadcast stations XETRA-FM (91.1 MHz), XHITZ-FM (90.3 MHz) and XHRM-FM (92.5 MHz) (collectively, the "Stations"). Each station is licensed in Tijuana, Mexico and has a maximum ERP of 100,000 watts.
