## Streamlined International Applications Accepted For Filing

### Section 214 Applications (47 C.F.R. §§ 63.18, 63.24); Section 310(b) Petitions (47 C.F.R. § 1.5000)

Unless otherwise specified, the following procedures apply to the applications listed below:

The international Section 214 applications listed below have been found, upon initial review, to be acceptable for filing and subject to the streamlined processing procedures set forth in Section 63.12 of the Commission's rules, 47 C.F.R. § 63.12. These applications are for authority under Section 214 of the Communications Act, 47 U.S.C. § 214(a), to transfer control of an authorized carrier or to assign a carrier's existing authorization; and/or (b) to become a facilities-based international common carrier; and/or (c) to become a resale-based international common carrier.

Pursuant to Section 63.12 of the rules, these Section 214 applications will be granted 14 days after the date of this public notice (see 47 C.F.R. § 1.4 regarding computation of time), and the applicant may commence operations on the 15th day, unless the Commission has informed the applicant in writing, within 14 days after the date of this public notice, that the application, on further examination, has been deemed ineligible for streamlined processing. Pursuant to Section 1.1910(b)(2) of the rules, action will be withheld on any application by any entity found to be delinquent in its debts to the Commission. Applicants should check the Red Light Display System's website at [www.fcc.gov/redlight](http://www.fcc.gov/redlight) to determine if they are delinquent in a debt to the Commission and for information on how to pay the debt.

Communications between outside parties and Commission staff concerning these applications are permitted subject to the Commission's rules for "permit-but-disclose proceedings." See 47 C.F.R. § 1.1206. An application can be removed from streamlined processing only in the sound discretion of Commission staff. The filing of comments or a petition to deny will not necessarily result in an application being deemed ineligible for streamlined processing.

**Current Licensee:** HRS Internet, LLC d/b/a Lightbound

**FROM:** Databank Holdings Ltd.

**TO:** Everstream Solutions LLC

Application filed for consent to the transfer of control of HRS Internet, LLC d/b/a Lightbound (HRS Internet), which holds international section 214 authorization ITC-214-20080612-00268, from its direct parent DataBank Holdings Ltd. (DataBank) to Everstream Solutions LLC (Everstream Solutions). Pursuant to a September 9, 2019, Membership Interest Purchase Agreement, Everstream Solutions will acquire all of the membership interests of HRS Internet from DataBank. Upon closing HRS Internet will become a wholly owned direct subsidiary of Everstream Solutions.

Everstream Solutions, an Ohio limited liability company, is a wholly owned subsidiary of Midwest Fiber Acquisition LLC (Midwest), a Delaware limited liability company. Midwest is directly owned by Midwest Fiber Holdings LP (Midwest Fiber Holdings), which in turn is directly owned by Midwest Intermediate US LP (Midwest Intermediate US), a Delaware limited partnership (97.43%). Midwest Intermediate US is owned by Midwest Fiber Midco LP (Midwest Fiber Midco), a Delaware limited partnership, (88.9%), and AMP Capital Global Infrastructure Fund II A LP (AMP CGIF II A), a Luxembourg holding company (11.1%). Midwest Fiber Midco is 100% owned by GIF II US Aggregator LP (GIF II US Aggregator), a Delaware limited partnership. GIF II US Aggregator is owned by AMP Capital Global Infrastructure Funds II B LP (AMP CGIF II B), a Luxembourg entity (76.59%) and AMP Capital Global Infrastructure Funds II C LP (AMP CGIF II C), a Luxembourg entity (23.41%). AMP Capital Investors (GIF II GP) S.a.r.l. (AMP Capital Investors GIF II), a Luxembourg entity is the general partner of each of AMP CGIF II A, AMP CGIF II B, and AMP CGIF II C.

AMP Capital Investors GIF II is wholly owned by AMP Capital Investors International Holdings Ltd, an Australian holding company that is wholly owned by AMP Capital Holdings Ltd (AMP Capital), an Australian holding company. AMP Capital is owned by AMP Holdings Ltd (85%) and minority owned by Mitsubishi UFJ Trust and Banking Corporation, a Japanese entity (15%), which is in turn wholly owned by Mitsubishi UFJ Financial Group, Inc., a publicly-traded widely held Japanese company. AMP Holdings Ltd is wholly owned by AMP Group Holdings Ltd, and Australian entity, which is wholly owned by AMP Limited, a publicly-traded widely held Australian company. Applicants state that no other individual or entity will hold a greater than 10% ownership interest in Everstream Solutions or HRS Internet.
