Mr. Koppel,

The application for an emergency STA filed by OptimERA, Inc. on April 7, 2020 is granted via this email. The applicant will be using the spectrum associated with AT&T's licenses (KNLG254 and WPOK573) in the area of Dutch Harbor, AK to provide relief during the state-of-emergency caused by the spread of COVID-19 throughout the United States. Applicant is advised that it must ensure proper protection of existing licensees and otherwise comply with the conditions described below.

This grant is for a period of 60 days, provided the applicant files a complete FCC Form 601 application for an STA to continue its operations in 1890-1910/1970-1990 MHz band within 10 days of today's date (April 8, 2020). If applicant fails to file a complete FCC Form 601 application by this date, its STA will terminate at midnight on that date. Applicant's use of the 1890-1910/1970-1990 MHz band is authorized on a non-interference basis and is limited by the conditions described below.

By utilizing the 1890-1910/1970-1990 MHz band pursuant to this STA, the applicant agrees to the following conditions:

- It understands that operations under this STA are subject to the general conditions of operation set forth in Part 24 of the Commission's rules (including that its access is not subject to interference protection) and that operations near Dutch Harbor, AK are limited to the area, as described in your email.
- It is responsible for ensuring that it does not cause interference to existing licensees. If a complaint of interference cannot be timely resolved, operation under this STA must cease.
- It understands that any emergency STA grant is conditioned on the applicant filing a formal STA application on FCC Form 601 (Radio Service Code CW) within 10 days of emergency STA grant.

## LETTER AGREEMENT

This Letter Agreement (the "Agreement") is entered into as of this 6th day of April, 2020 (the "Effective Date"), by and between AT&T Services, Inc. on behalf of itself and its affiliates ("AT&T") and OptimERA Inc "OptimERA".

- 1. This Agreement is entered into to enable OptimERA to provide certain services as part of its COVID-19 emergency response measures;
- 2. OptimERA plans to seek Special Temporary Authority (STA) to operate on certain frequencies licensed to AT&T in the PCS band in Dutch Harbor, Alaska as specified in Attachment 1 ("the spectrum");
- 3. Subject to the conditions below, AT&T hereby consents to OptimERA use of the spectrum in accordance with an STA.

## Conditions

- OptimERA shall use the spectrum exclusively as part of the company's COVID-19 emergency response measures;
- OptimERA shall provide AT&T, upon request, information regarding its COVID-19 emergency response measures as such measures pertain to the use of the spectrum;
- OptimERA shall not make any further use of the spectrum after the expiration of the STA;
- OptimERA shall be solely responsible for using the spectrum in accordance with all applicable laws including the Communications Act of 1934, as amended, and the rules, regulations, orders, decisions and written policies of the FCC, as well as any conditions imposed by the FCC in connection with the STA;
- OptimERA shall submit any applications needed to obtain the STA; and
- OptimERA agrees to indemnify AT&T for any claim, damages, fines or losses that arise from Optimera's use of the spectrum.
