Transfer of Control

Current Licensee: TracFone Wireless, Inc.

FROM: America Movil S.A.B. de C.V.

TO: Verizon Communications Inc.

Application filed for consent to the transfer of control of TracFone Wireless, Inc. (TracFone), which holds international section 214 authorization ITC-214-20030401-00162, from its 100% indirect parent, América Móvil S.A.B. de C.V. (América Móvil), to Verizon Communications Inc. (Verizon). Pursuant to an agreement dated September 13, 2020, América Móvil will sell all of its interests in TracFone to Verizon in exchange for \$3.125 billion in cash and \$3.125 billion in Verizon common stock. The agreement also includes up to an additional \$650 million in future cash consideration related to the achievement of certain performance measures and other commercial arrangements. Upon completion of the transaction, TracFone will become a wholly owned direct subsidiary of Verizon, and TracFone's subsidiaries will become wholly owned indirect subsidiaries of Verizon.

Verizon is a publicly traded Delaware corporation. Applicants state that no person or entity holds a direct or indirect 10% or greater ownership interest in Verizon. Applicants further state that América Móvil will hold less than a 5% ownership interest in Verizon post-closing.
