Re: *AT&T Florida v. Florida Power & Light Co.*, Proceeding No. 20-214

Dear Counsel:

This letter grants the parties' Joint Motion for Extension of Time (Motion) requesting that we extend the time for the parties to file their Joint Statement from December 21, 2020 to January 15, 2021.¹

The schedule for this proceeding was first established in the Scheduling Order, which stated that the Joint Statement was to be filed by September 3, 2020.² Defendant Florida Power & Light (FPL) then filed three unopposed motions seeking extensions of time, which were granted in large part, and which resulted in the filing date for the Joint Statement being extended to December 21, 2020.³ Granting the Motion's requested extension to January 15, 2021 means that the Joint Statement will be filed 134 days beyond the September 3, 2020 date established in the Scheduling Order. As a result, we extend the 270-day review period for final action on the complaint in this proceeding by 134 calendar days.
