Momentum Inc. requests special temporary authority for a period of 180 days to operate a non-geostationary spacecraft to be known as Vigoride-1, designed to deploy five customer spacecraft in low-Earth orbit. Momentum seeks authority to operate in the 2025-2110 MHz (Earth-to-space) and 400.15-401 MHz (space-to-Earth) frequency bands for space operation communications. Specifically, Momentum seeks authority to operate an uplink with a center frequency of 2075.0 MHz and bandwidth of 0.1 MHz and a downlink with a center frequency of 400.5 MHz and bandwidth of 0.04 MHz. Momentum seeks waiver of the U.S. Table of Frequency Allocations, Section 2.106 of the Commission's rules, as well as waiver of Section 25.113(g) of the Commission's rules.
