Intelsat License LLC, as debtor-in-possession, requests special temporary authority, for an additional period of 180 days, to continue to operate the JCSAT-RA space station at the 168.9° E.L. orbital location to provide fixed-satellite service in the 3940-4200 MHz (space-to-Earth), 6225-6485 MHz (Earth-to-space), 12.2-12.75 GHz (space-to-Earth), and 13.75-14.5 GHz (Earth-to-space) frequency bands. Intelsat also seeks authority to continue to conduct telemetry, tracking and command operations necessary to maintain JCSAT-RA at the 168.9° E.L. location using the center frequencies of 13.9935 GHz and 14.496 GHz (Earth-to-space); and 4199.55 MHz, 12.2485 GHz, 12.7472 GHz, 12.74835 GHz and 12.74975 GHz (space-to-Earth). Intelsat requests that the prior waivers of section 2.106 of the Commission's rules, regarding operations of JCSAT-RA in the 12.2-12.7 GHz and 12.7-12.75 GHz frequency bands continue to be extended to operations of JCSAT-RA at 168.9° E.L.
