NOTICE OF UNLICENSED OPERATION

Case Number: EB-FIELDNER-22-00033570

On April 13, 2022, in response to a complaint, an Agent from the New York Office of the Federal Communications Commission's (FCC or Commission's) Enforcement Bureau (Bureau) confirmed by direction finding techniques that radio signals on frequency 464.675 MHz were emanating from a Car Service, Magnificent 7 S Enterprises Inc. (Magnificent), at 10-85 Beach 21st Street, Far Rockaway, New York 11691. The Commission's records show that the land mobile radio station license KQY480 issued to Magnificent for operation on the frequency 464.675 MHz at this location in Far Rockaway, New York expired in February 11, 2021, was cancelled in April 17, 2021, and no renewal application is pending.

Radio stations operating on certain frequencies,¹ including 464.675 MHz, must be licensed by the FCC pursuant to Section 301 of the Communication Act of 1934, as amended (Act).² On April 13, 2022, you operated on frequency 464.675 MHz without an authorization. Thus, this station was operating in violation of Section 301 of the Act.³

You are hereby warned that operation of radio transmitting equipment without a valid radio station authorization constitutes a violation of the Federal laws cited above and may subject the operator to severe penalties, including, but not limited to, substantial monetary fines, *in rem* arrest action against the offending radio equipment, and criminal sanctions, including imprisonment.⁴

UNLICENSED OPERATION OF THIS RADIO STATION MUST BE DISCONTINUED IMMEDIATELY.

You have ten (10) days from the date of this notice to respond with any evidence that you have authority to operate granted by the FCC. Your response should be sent to the address in the letterhead and reference the listed case number. Under the Privacy Act of 1974,5 we are informing you that the Commission's staff will use all relevant material information before it to determine what, if any, enforcement action is required to ensure your compliance with FCC Rules. This will include any information that you disclose in your reply.
