	Comment #1 Dismissed 5/6/2024 via Public Notice for the following reason: Section 73.807 violation with respect to the second adjacent facilities for KVOO-FM (BMLH-20170718AEG), Tulsa, OK (required spacing = 93 km, proposed spacing = 26 km). The applicant recognizes this short-spacing and requests waiver of 73.807. However, per DA 23-642, an LPFM applicant seeking a 2nd adjacent waiver must include an engineering study demonstrating that its proposed station will not cause interference to any authorized radio service. The Bureau will dismiss any application that fails to comply with the second-adjacent channel spacing requirements which does not contain an engineering exhibit in support of this waiver, and the applicant will not be permitted to seek nunc pro tunc reinstatement of its application. The waiver request includes a statement about the antenna being mounted 37.2 meters away from residential structures to prevent interference, but it fails to include any sort of exhibits to explain how it came up with that distance and why that distance is sufficient to prevent interference. The waiver also fails to address interference within the co-located church. The application fails to provide any engineering studies demonstrating that the proposed station will not cause interference to any authorized radio service.
