Zetexa Global Corporation (Zetexa Global) has filed an application for authority to provide facilities-based service in accordance with section 63.18(e)(1) of the Commission's rules and resale service in accordance with section 63.18(e)(2) of the Commission's rules. 47 CFR § 63.18(e)(1), (2).

Zetexa Global, a Delaware corporation, is wholly owned by Zexta Global Private Limited (Zetexa Private), an India entity. Zexta Private is owned by Shalu Agarwal (45.44%), a citizen of India; Krishna Murthy Yeleti (20.47%), a citizen of India; and Power Mech Infra Pvt Ltd (Power Mech) (34.09%), an India entity. The 10% or greater owners of Power Mech are two citizens of India: Sajja Rohit (59.973%) and Sajja Vignatha (39.933%).

Pursuant to Commission practice, the application is being referred to the relevant Executive Branch agencies for their views on any national security, law enforcement, foreign policy or trade policy concerns related to the proposed foreign ownership of Zetexa Global. On May 29, 2024, the Chair of the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector (Committee) notified the Commission that the Committee is conducting an initial review of the application for international section 214 authority filed by Univasa LLC to assess whether grant of the application will pose a risk to the national security or law enforcement interests of the United States, pursuant to Executive Order 13913 (85 Fed Reg 19643 (April 8, 2020)). The Committee shall complete its review of the application before the end of the 120-day initial review period, unless the Committee notifies the Commission of an extension of the 120-day initial review period or the need arises to conduct a 90-day secondary assessment.
