

# Communications Status Report for Areas Impacted by Hurricane Helene October 1, 2024

The following is a report on the status of communications services in geographic areas impacted by Hurricane Helene as of October 1, 2024, at 9:00 a.m. EDT. This report incorporates network outage data submitted by communications providers to the Federal Communications Commission (FCC) Disaster Information Reporting System (DIRS). Hurricane Helene made landfall in Florida on Thursday, September 26, 2024. Note that the operational status of communications services during an event may evolve rapidly, and this report represents a snapshot in time.

On September 27, 2024, the activation area for Hurricane Helene was expanded to include additional counties in South Carolina, Tennessee, and Virginia.

On September 30, 2024, the FCC reduced reporting for certain counties in Florida and Georgia.

The following counties in Florida, Georgia, North Carolina, South Carolina, Tennessee, and Virginia are in the current geographic area that is part of the DIRS activation area (the "disaster area") for today's report.



#### 911 Services

The Public Safety and Homeland Security Bureau (PSHSB) learns the status of services provided to each Public Safety Answering Point (PSAP) through the filings of 911 Service Providers in DIRS, reporting to the FCC's Public Safety Support Center, coordination with state and territory 911 Administrators, and, if necessary, direct contact with individual PSAPs.

## Florida:

There are no PSAPs reported in DIRS as being affected by Hurricane Helene in Florida.

#### Georgia:

The following PSAPs are operational without ALI: Bacon County, Toombs County, and Tri County (Lakeland).


There are 3.5% (down from 6.8%) of cell sites reported as being out of service in the areas of Virginia impacted by Hurricane Helene.

The number of cell site outages in a specific area does not necessarily correspond to the availability of wireless service to consumers in that area. *See* Improving the Resiliency of Mobile Wireless Communications Networks, Order, 31 FCC Rcd 13745, para. 10 (2016) (recognizing the difficulties in accurately depicting the ongoing status of a wireless provider's service during emergencies). Wireless networks are often designed with numerous, overlapping cell sites that provide maximum capacity and continuity of service even when an individual site is inoperable. In addition, wireless providers frequently use temporary facilities, such as cells-on-wheels (also known as COWs), increase power at operational sites, initiate roaming agreements, or take other actions to maintain service to affected consumers during emergencies or other events that result in cell site outages.

#### **Cable Systems and Wireline (Combined)**

Cable and wireline companies reported 796,999 subscribers out of service in the disaster area. This includes the loss of telephone, television, and/or Internet services.

# Television station status:

Florida: There are no TV stations reported as being out of service.

Georgia: There are 3 (up from 2) TV stations reported as being out of service.

North Carolina: There are 2 (no change) TV stations reported as being out of service.

South Carolina: There are no TV stations reported as being out of service.

Tennessee: There are no TV stations reported as being out of service.



Virginia: There are no TV stations reported as being out of service.

## FM Radio station status:

Florida: There is 1 (no change from yesterday) FM station reported as being out of service.

Georgia: There are 20 (up from 18) FM stations reported as being out of service.

North Carolina: There are 3 (up from 2) FM stations reported as being out of service.

South Carolina: There are 8 (down from 9) FM stations reported as being out of service.

Tennessee: There are no FM stations reported as being out of service.

Virginia: There is 2 (up from 1) FM station reported as being out of service.

## AM Radio station status:

Florida: There are no AM stations reported as being out of service.

Georgia: There are 4 (up from 3) AM stations reported as being out of service.

North Carolina: There is 1 (down from 2) AM station reported as being out of service.

South Carolina: There is 1 (down from 2) AM station reported as being out of service.

#### **Mandatory Disaster Response Initiative**

The Mandatory Disaster Response Initiative was activated for Hurricane Helene response activities on September 26, 2024. As a reminder, all facilities-based mobile wireless providers operating in the above-referenced areas are hereby notified and required to: (1) provide for reasonable roaming under disaster arrangements when technically feasible;<sup>2</sup> (2) activate mutual aid arrangements with other facilities-based mobile wireless providers for providing aid upon request to those providers during emergencies;<sup>3</sup> (3) take reasonable measures to enhance municipal preparedness and restoration; (4) take reasonable measures to increase consumer readiness and preparation; and (5) take reasonable measures to improve public awareness and stakeholder communications on service and restoration status.<sup>4</sup>

# Special Temporary Authority (STA)/Waivers/Extensions

The Federal Communications Commission (FCC) may grant Special Temporary Authority (STA) to permit immediate or temporary operation of certain radio facilities during emergencies or other urgent conditions, as well as waivers to support emergency communications and service restoration.

wireline operators who transmit emergency alerts from public safety authorities—to submit required annual filings concerning their EAS equipment from October 4 to October 18, 2024, in recognition of the burdens on communications providers of responding to Hurricane Helene.
