NOTICE OF VIOLATION

Released: December 2, 2025

By the Regional Director, Region One, Enforcement Bureau:

- 1. This is a Notice of Violation (Notice) issued pursuant to section 1.89 of the Commission's rules¹ to EMAC Communications, LLC and EDMAC, LLC, reputed owner(s) of antenna structure number ASR 1209826 (Antenna Structure) in Seymour, Connecticut. Pursuant to section 1.89(a) of the Commission's rules, issuance of this Notice does not preclude the Enforcement Bureau from further action if warranted, including issuing a Notice of Apparent Liability for Forfeiture for the violations noted herein.²
- 2. On July 31, 2025, an agent of the Enforcement Bureau's New York Office began investigating a complaint regarding the Antenna Structure. During the FCC's investigation, the following violation was identified:
 - a. 47 CFR § Part 17.57: "The owner of an antenna structure for which an Antenna Structure Registration Number has been obtained must notify the Commission within 5 days of completion of construction by filing FCC Form 854-R and/or dismantlement by filing FCC Form 854. The owner must also notify the Commission within 5 days of any change in structure height or change in ownership information by filing FCC Form 854. FCC Forms 854 and 854-R, and all related amendments, modifications, and attachments, shall be filed electronically." EMAC Communications, LLC and/or EDMAC, LLC failed to notify the FCC of the change in address, phone, and email contact information.³
- 3. Pursuant to section 403 of the Communications Act of 1934, as amended (Act), and section 1.89 of the Commission's rules, we seek additional information concerning the violations and any

remedial actions taken.⁴ Therefore, EMAC Communications, LLC and EDMAC, LLC must submit a written statement concerning this matter within twenty (20) days of release of this Notice. The response (i) must fully explain each violation, including all relevant surrounding facts and circumstances, (ii) must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and (iii) must include a time line for completion of any pending corrective action(s). The response must be complete in itself and must not be abbreviated by reference to other communications or answers to other notices.⁵

- 4. In accordance with section 1.16 of the Commission's rules, we direct EMAC Communications, LLC and EDMAC, LLC to support the response to this Notice with an affidavit or declaration under penalty of perjury, signed and dated by authorized officers of EMAC Communications, LLC and EDMAC, LLC with personal knowledge of the representations provided in the response, verifying the truth and accuracy of the information therein, and confirming that all of the information requested by this Notice which is in EMAC Communications, LLC's and EDMAC, LLC's possession, custody, control, or knowledge has been produced.⁶ To knowingly and willfully make any false statement or conceal any material fact in reply to this Notice is punishable by fine or imprisonment under title 18 of the U.S. Code.⁷
