The applicant recognizes this short-spacing and indicates that there "...is an approximately 60-meter difference between the actual WRML-LP tower coordinates and the coordinates published in the FCC data." The applicant indicates that if the WRML-LP licensed coordinates were corrected to specify the actual location of the WRML-LP tower, the WYYO-LP proposal would be fully-spaced to WRML-LP.
