**ORDER**

By the Commission: Chairman Genachowski and Commissioner Clyburn issuing separate statements.

1. Pursuant to sections 254(a)(1) and 410 of the Communications Act of 1934, as amended (the Act),<sup>1</sup> the Commission appoints the Honorable Jessica Rosenworcel, Commissioner of the Federal Communications Commission, and the Honorable Ajit Pai, Commissioner of the Federal Communications Commission, to serve on the Federal-State Joint Board on Universal Service (Universal Service Joint Board) and the Federal-State Joint Board on Jurisdictional Separations (Separations Joint Board). In addition, the Honorable Julius Genachowski, the Honorable Robert McDowell, the Honorable Mignon Clyburn, Commissioner Rosenworcel, and Commissioner Pai are members of the Federal-State Joint Conference on Advanced Services (Joint Conference) by virtue of their positions on the Commission.<sup>2</sup> Commissioner Rosenworcel shall further serve as the federal chair of the Universal Service Joint Board, the Separations Joint Board, and the Joint Conference. Her term as federal chair shall begin upon adoption of this Order, with the exception of the Joint Conference which shall begin on February 8, 2013. The Commission gratefully acknowledges the contributions of Commissioner Clyburn in her service as chair of the Universal Service Joint Board, the Separations Joint Board, and the Joint Conference.
