ORDER TO SHOW CAUSE

Based on information recently discovered, which has been corroborated by OALJ staff, William L. Zawila (“Zawila”) is hereby **ORDERED TO SHOW CAUSE** why he cannot or will not send and receive courtesy copies of filings via email address *william.zawila@yahoo.com*, in

light of the fact that such email address is registered with the California State Bar under Zawila's California Bar Number, #60223.¹

Specifically:

- (1) Zawila must file, submit, and serve a signed Declaration under penalty of perjury providing explanation in full, admitting or denying that he has access to email address *william.zawila@yahoo.com*.²
- (2) If Zawila denies that he has the right and/or ability to use email address *william.zawila@yahoo.com*, Zawila shall explain in his Declaration why such email address is on file with the California State Bar. Alternatively, if he admits that he has the right and ability to use email address *william.zawila@yahoo.com*, he shall explain in his Declaration why he has denied the fact and/or refused to acknowledge having such email address for use in this case.
- (3) Zawila's Declaration shall explain in detail any credible excuse and/or reasoned explanation for failing and/or refusing to use email in sending or receiving correspondence, pleadings, and orders in EB Docket No. 03-152, utilizing *william.zawila@yahoo.com*.
- (4) Zawila shall admit or deny in his Declaration that he is able to file **all** future pleadings, correspondence, and papers with the Commission through the FCC's Electronic Comment Filing System ("ECFS") website, given that ECFS records reflect that Zawila has done so on prior occasions, albeit not consistently.
- (5) Zawila's Declaration shall provide reasoned, credible, and detailed explanation as to why the Presiding Judge and/or the Enforcement Bureau, when attempting to send courtesy copies via fax to Zawila, have been delayed due to repeated lack of paper or other problems experienced in reaching Zawila's fax machine at (714) 636-5042.

Additionally:

Zawila shall show cause why the Presiding Judge should not add an issue on the question of whether Zawila misrepresented and/or lacked candor in failing to disclose in this proceeding email address *william.zawila@yahoo.com*, which appears in his attorney record #60223 at the California State Bar, and whether such failure to disclose and utilize email address

² To the extent Zawila has an **alternate email address** that he has the right and ability to use, he shall disclose such email address to the extent that he cannot or will not use *william.zawila@yahoo.com*.

william.zawila@yahoo.com, or some other email address, should disqualify Zawila from holding a Commission permit.

Zawila shall further show cause why he should not be assessed a monetary forfeiture based on his responses to this Order to Show Cause.

Finally:

Zawila shall review all of his ECFS filings in this case and, following such review, Zawila shall submit copies to ECFS of all pleadings and papers found missing from ECFS no later than **March 23, 2016**. Upon completion, Zawila shall immediately advise all counsel and the Presiding Judge that the entirety of his pleadings and papers appear on ECFS.³

Service:

All Pleadings and Declaration(s) in response to this Order to Show Cause shall be filed, submitted, and served by Zawila, in accordance with Commission rules on filing and service, on or before the close of business on **March 17, 2016**.

Courtesy copies shall be sent via email by Zawila to all counsel and the Presiding Judge, and copies of all pleadings and papers shall be filed by Zawila on ECFS.
