This Order summarizes the prehearing conference conducted in the above-captioned matter on July 9, 2019, at FCC Headquarters.¹ The purpose of the prehearing conference was to establish a schedule for discovery and hearing. The procedural schedule agreed upon is as follows:

Deadline for Completion of Discovery	February 21, 2020
Last Day to Request Summary Decision	April 3, 2020
Completion of Exchange of Exhibits ² and Witness Lists	June 1, 2020
Deadline for Filing of Written Affirmative Direct Cases	June 1, 2020
Deadline for Notification of Witnesses Intended for Cross-Examination	June 8, 2020
Deadline for Filing Objections to Affirmative Direct Case Exhibits and Written Testimony	June 15, 2020
Deadline for Filing Replies to Objections	June 22, 2020
Commencement of Hearing	July 13, 2020 ³

IT IS ORDERED that the procedural schedule stated herein is adopted.

IT IS FURTHER ORDERED that the parties shall file status reports with the Presiding Judge on the first Tuesday of every month, commencing August 6, 2019.⁴

IT IS FURTHER ORDERED that rulings requested of the Presiding Judge seeking to resolve disputes encountered during the discovery phase of this proceeding shall include a certification that the parties made a good-faith effort to resolve the conflict but have reached an impasse.

IT IS FURTHER ORDERED that, to the extent that the procedural rules governing this hearing proceeding, found at 47 C.F.R. Part 1, Subparts A and B, require the filing of multiple copies of written



pleadings, the parties shall instead file via the Commission's Electronic Comment Filing System (ECFS) by 11:59 PM Eastern Time on the filing date.

IT IS FURTHER ORDERED that, to the extent that the procedural rules governing this hearing proceeding, found at 47 C.F.R. Part 1, Subparts A and B, require service by postal mail, the parties shall instead achieve service via electronic mail whenever possible.
