ORDER TERMINATING PROCEEDING

1. On April 2, 2021, the FCC's Media Bureau initiated this hearing proceeding to determine whether the above-captioned application for renewal of license of WJEH(AM), Gallipolis, Ohio, should be granted or denied in light of the station's record of extended silence and reduced power.¹ The licensee, Vandalia Media Partners 2, LLC (Vandalia), filed a timely Notice of Appearance as required by section 1.221(c) of the Commission's rules, and an initial status conference was held on April 28, 2021.² On May 17, 2021, Vandalia filed a request withdrawing its Notice of Appearance and seeking dismissal of its application for renewal.³ The Enforcement Bureau responded on May 18, 2021, that it does not object to dismissal of the application and termination of this hearing.⁴

2. Section 1.221(c) of the Commission's rules, 47 CFR § 1.221(c), directs that when an application has been designated for hearing, the applicant must file a written appearance within 20 days indicating that the applicant will present evidence and appear at the hearing. Where an applicant fails to do so, section 1.221(c) provides that the application will be dismissed with prejudice for failure to prosecute. Vandalia's withdrawal of its Notice of Appearance has the same effect as if it was never filed. As a result, its renewal application is dismissed and this hearing is terminated.

3. Accordingly, **IT IS ORDERED** that, pursuant to Section 1.221(c) of the Commission's rules, 47 CFR § 1.221(c), the above-captioned application **IS DISMISSED WITH PREJUDICE**.

IT IS FURTHER ORDERED that the hearing proceeding in the above-captioned matter **IS TERMINATED**.


