**ORDER SUMMARIZING INITIAL STATUS CONFERENCE**

1. This Order summarizes the initial status conference conducted in the above-captioned matter held on March 31, 2022. The purpose of the initial status conference was to establish a schedule for discovery and filing of pleadings in this proceeding.

2. The FCC's Media Bureau initiated this hearing proceeding on February 8, 2022, by Hearing Designation Order and Notice of Opportunity for Hearing.<sup>1</sup> This hearing will be based on a written record pursuant to sections 1.371 through 1.377 of the Commission's rules, 47 CFR §§ 1.371 – 1.377.<sup>2</sup> The schedule established during the prehearing conference is as follows:

Deadline to Submit Pre-Hearing Motions	May 2, 2022
Deadline for Completion of Discovery	October 3, 2022
Snake River's Affirmative Case Due	November 2, 2022
Enforcement Bureau's Responsive Case Due	December 2, 2022
Snake River's Reply Case Due	January 3, 2023
Deadline to File Motion to Request Oral Hearing	January 17, 2023
Deadline to File Motion to Submit Additional Pleadings <sup>3</sup>	January 17, 2023

In addition, due to the potential for settlement, the parties are to file a status report on or before May 2, 2022.



4. **IT IS FURTHER ORDERED** that the parties **SHALL FILE** a status report regarding potential settlement of this proceeding on or before **May 2, 2022**.
5. **IT IS FURTHER ORDERED** that all written submissions in this proceeding shall be filed using the Commission's Electronic Comment Filing System (ECFS) by 11:59 PM Eastern Time on the filing date.
6. **IT IS FURTHER ORDERED** that the parties shall serve all filings on each other via electronic mail.<sup>4</sup>
7. **IT IS FURTHER ORDERED** that the parties are reminded that they are expected to be fully cognizant of Part 1 of the Commission's rules concerning practice and procedure, 47 CFR Part 1, Subparts A and B.
